The District Educational Officer, Vizianagaram has verified the application for provision on recognition to Vizag International School, Korukonda under Vestal Educational Society with reference to the inspection report of the inspecting Officer and also with reference to the conditions laid down in the permission (English Medium) with classes I-VII.

After careful examination of the ref. Cited ad the conditions prescribed in G.O.Ms.No.1 Education, Dt.01.01.1994 the competent authority is hereby according recognition to Vizag International School, Korukonda under Vestal Educational Society for a period of 05 years commencing from the academic year 2008-2009 to 2012-13 for classes I to VII (TM) (i.e.) from 12.06.2008 to 31.05.2013 subject to fulfilment of the following conditions.

1. That the society should abide by the instructions / rules and regulations made by the Government or authorised officer time to time.
2. That the Educational Institutions should observe the needs of the locality more particularly.
3. That the Institutions should adopt the curricula and Syllabus prescribed from time to time.
4. The School timings , vacations and mid-term holidays should be as prescribed by the Government from time to time.
5. That the qualified staff with in the age limits prescribed by the Government employees should be appointed as per the staff pattern and the appointment should be made as per G.O.Ms.No.1 Edn.(PS.2) Dt.01.01.1994.
6. That the results of Institutions should be satisfactory every year.

7. That the list of Governing body should be furnished to the District Educational Officer every year.
8. That the records / accounts should be furnished to the District Educational Officer every year by 31st of May of the latest.
9. That the pay structure/ fee structure fixed by the Governing body should be get approved by the District Educational Officer every year.
10. That all the conditions prescribed in the G.Os and other orders which are not specified in this order should be complied with.
11. That the school should not be closed without giving notice both to the parents/DISTRICT EDUCATIONAL OFFICER, and competent authority at least 6 months before.
12. That the school should be closed or permitted to be closed only from the date on which summer vacation declared.
13. That the society should submit proposals for renewal of provisional recognition sufficiently in advance i.e. at least 6 months before prior to the date of expire of the renewal.
14. The management should constitute the Governing Day as per the rule 15 of G.O.Ms.No.1 Education, Dt.01.01.1994.
15. The Management should provide adequate, Library books, TLM furniture to the school.
16. The Management should observe clean & Green and Implement Govt. Instructions.
17. The Management should replace the unqualified teachers with qualified one.
18. The Endowment Grant should be converted into Joint account in favour of DISTRICT EDUCATIONAL OFFICER and Correspondent.
19. The economic strength should be maintained in every class.
20. The management shall produce Fire Safety Certificate from District Fire Officer within one month from the date of receipt of the order.


